REQUESTING THE ARMM REGIONAL GOVERNOR, HON. MUJIV S. HATAMAN TO FAVORABLY APPROVE AND SIGN THE FINAL DRAFT OF THE IMPLEMENTING RULES AND REGULATION (IRR) OF MUSLIM MINDANAO ACT NO. 323, KNOWN AS THE REGIONAL DARUL IFTA' ACT OF 2015.

WHEREAS, it is the state policy and principle of the Philippine Government to afford the constitutional rights to its citizen to have freedom of religion, to profess religious beliefs and recognize their cultures and traditions;

WHEREAS, it is also a declared policy of Autonomous Regional Government in Muslim Mindanao to recognize the rights and well-being of the Bangsamoro with due regard to their beliefs, customs, traditions and institutions, and to further ensure their contributions to the regional government's goals and aspirations;

WHEREAS, for this purpose the Autonomous Regional Government shall give priority consideration to the organization of the Regional Darul Ifta' which shall be primarily responsible for the promulgation and issuance of legal opinions (fatawa) pertaining to Muslim personal laws and jurisprudence pursuant to Article VIII, Sec. 20 of RA 9054;

WHEREAS, the MUSLIM MINDANAO AUTONOMY ACT NO.323 otherwise known as " the Regional Darul Ifta' Act of 2015" has been officially approved by the ARMM Regional Governor, HON. MUJIV S. HATAMAN on Nov. 11, 2015; and

WHEREAS, the Implementing Rules and Regulations necessitate its prompt promulgation to prescribe clear guidelines, procedures and standards for the implementation of MUSLIM MINDANAO AUTONOMY ACT NO. 323 in order to facilitate compliance therewith and achieve the objectives thereof as well as to capacitate the RDI-ARMM to effective and efficiently operate its transaction and carry out its mandates in both regional and provincial levels;

NOW, THEREFORE, in the special session of the RDI-ARMM Fatwa Council and on motion of ALIM ABDULMUHMİN MUJAHID, t and duly seconded by the Body, BE IT RESOLVED as it is hereby resolved by consensus to approve and adopt this Resolution No.----- Series of 2017 **REQUESTING THE ARMM REGIONAL GOVERNOR, HON.
