Whereas, Pursuant to Article VIII, Sec. 20 of RA 9054; the Jurisconsult in Islamic Law or the Regional Darul-Ifta’ which is primarily responsible for the promulgation and issuance of legal opinions (fatawa) pertaining to Muslim personal laws and jurisprudence, has been created under the MUSLIM MINDANAO AUTONOMY ACT NO. 323 otherwise known as “the Regional Darul Ifta’ Act of 2015” which was officially approved by the ARMM Regional Governor, HON. MUJIV S. HATAMAN on Nov. 11, 2015;

Whereas, in pursuit of undertaking its vital mandate in the promulgation of the issuance of fatawa (legal opinions) pertaining to the whole breath of Islamic jurisprudence including refutation against Violent Extremism and Terrorism which have long been distorting the good image of Islam and the Ulama in the ARMM in particular;

Whereas, Regional Darul-Ifta’ and its Ulama found **GENERAL CARLITO G. GALVEZ JR.** of the Armed Forces of the Philippines to be very supportive in helping the Ulama eradicate Violent Extremism and Terrorism through his humble and magnanimous participation during the *Ulama Summit Against Terrorism* on May 11, 2017 in Zamboanga City and *Ulama Summit on Peace and Security* on October 12-25, 2017 in Cotabato City wherein the impact led to the gradual return of many lawless elements to the fold of government and discouragement of the youth venerating the inhumane act of terrorism.

NOW, THEREFORE, in the 2nd Regular Session of the RDI-ARMM Fatwa Council and on motion of **MUFTI JAAFAR M.
